Bass-Fox Legal Drain-Taylor Sumerford told the Drainage Board that Doug Theobald had offered to do some brush removal and bottom dipping on the Bass-Fox Legal Drain at his own expense. Roberts Legal Drain-Jim Hunter came before the Board to discuss some concerns he has concerning the Roberts Legal Drain. Mr. Hunter asked the Board what herbicide was used when the ditch gets sprayed as he was concerned about the strength, and the fact that the ditch is close to his house and trees. Kevin Nigh told Mr. Hunter that the sprays used are usually either Crossbow or Rodeo and the purpose of the spraying is to keep down the wooded brush and Canadian thistle. Kevin assured Mr. Hunter that the sprayers are licensed and certified. Mr. Hunter said that he was worried about his young trees and he wondered whether the spray could be used more sparingly by those. Mr. Hunter also asked if some of the fence on the border of the ditch and David Lawson's field might possibly be removed so that the spraying could be done from the fence side of the ditch instead of on his side of the ditch. David Mohr asked Taylor Sumerford if he thought that the sprayers could work with Mr. Hunter to try to preserve some of the trees that he is concerned about and that he felt that the sprayers would be very cautious about the drift of the spray when they were working in Mr. Hunter's area. Taylor suggested to Jim that after the mechanical side of the ditch cleaning is done by Larry Mohr in that area...he and Mr. Hunter meet to discuss the matter. David said that he thought David Lawson might actually remove the fence as he wants the ditch cleaned out. Taylor said that he would ask Mr. Lawson about that. Kevin assured Mr. Hunter that they would work with him.

Set date for Spraying Bids-Kevin Nigh made a motion to have the bids for spraying the County Legal Drains be brought in by 8:00am on March 11, 2013, 2nd Don Parker, vote 3/0.

Ditch Assessments-Taylor Sumerford brought before the Board a list that Norma Ross had provided of ditch assessment deletion suggestions for 2013. Mr. DeBaun said that it would help the Thompson Ditch. John stated that was understood... and that perhaps it could be a cooperative effort with the Commissioners saying, "We endorse the Corp of Engineers and Congress looking into this as it would have a trickle-down effect, alleviating some dumpage into the Thompson Ditch which directly affects Shelby County." Mr. DeBaun asked the Drainage Board to look at the log jams and look into the situation.

Cotton Run-Mohler Green Ditches- Taylor Sumerford told the Drainage Board that he had received a letter from Mrs. Linville about the Cotton Run-Mohler Green Ditches. Taylor asked the Board how they would like him to respond. Clark, Carter, Mohr & Hankins Ditches-Doug Theobald and Dave Brown came before the Drainage Board to discuss their concerns regarding the Clark, Carter, Mohr and Hankins Ditches. They brought before the Board a map that Jim Brown had made for them, so they could point out some of the trouble spots. They said there is a big problem with about a mile and a half stretch of the Clark Ditch, from Boggstown Rd. to Brandywine, where there is approximately 3 to 4 feet of silt that needs to be removed from the bottom of the ditch and that the banks there need to be reshaped. Additional problems include trees that need

to be removed and the fact that there are 3 beaver dams stopping the normal water flow. Doug, Dave and the Drainage Board discussed the possibility of combining the watersheds of all four ditches into one, and collecting ditch assessment funds from the affected property owners in order to fund the work that needs to be done. Jim Brown's map of the acreage that combining all four would cover, included around 19,000 acres and 1,671 properties. As the discussion progressed, it was determined that the watershed areas of the Carter and Hankins ditches, and not all four, would be more appropriate. Jim stated that he would create a new map of that watershed and also a list of names and addresses of the affected property owners. The Board explained to Doug and Dave the steps that would need to be taken to set up a public hearing for these owners...the first step being to pick up a petition form from Taylor Sumerford and collecting signatures from property owners who were interested in improving the drainage in this watershed. The Board explained to Doug and Dave that they would need to collect at least 51% of the owners' signatures in order to set up a public hearing. Taylor will contact some of the contractors who have done work for the Drainage Board and ask them about pricing to do this project, in order to have a cost estimate ready for property owners in the event a public hearing is arranged. The Board said that if this project is set in motion, it would need to be done in phases.....doing the work as the assessment funds are brought in.

Ditch Spraying-Taylor Sumerford informed the Drainage Board that the ditch spraying contractors intend to start spraying on June 24th.

Clif said they now know that they are not to damage any standing crops, spray the brush and any concentration of vegetation. Kevin thanked Clif for watching out for the County's best interests.

Cotton Run-Taylor Sumerford showed the Board a letter that he had received from Mrs. Linville, who was requesting that the Drainage Board vacate a portion of the Cotton Run Legal Drain. One of the reasons she gives is that they have organic beef. Taylor talked to Scott Gabbard, (with Purdue). Scott called Purdue to see if Purdue had a record of certification for the Linvilles, but had not gotten a call back yet. Kevin Nigh said that watershed is a very important watershed with over 1,500 acres. Many property owners pay a watershed fee in order to keep that drain maintained...so it is important to stick with the program. Kevin Nigh made a motion to approve Taylor Sumerford sending his reply letter to Mrs. Linville which states that her request to vacate a portion of the Cotton Run Legal Drain is denied.
